- h. Street and other township signs – Motion by Christina Gardner, supported by Wareham to approve the signage being ordered. Roll call vote: 4 yea, 0 nay, 1 absent. Motion carried.
- i. ARPA Funds use plan – Will be presented at the May 8 meeting.
- j. Retirement update – No additional information at this time. Will be prepared for the May 8 meeting.
- k. Dust control contract – Road commission has sent their costs, requesting a response by May 10. Will do the same roads as last year.
- l. Gooseneck Location grant – We received \$176,000. There will be a bid process.
  - a. Gooseneck replacement FY 24-25 – Contact the contractors to defer the replacements on Elm Avenue to next summer.
- m. Audit – Motion by Christa Gardner, supported by Christina Gardner to accept the Rukkila/Negro offer for an audit on FY 23-24. Roll call vote: 4 yea, 0 nay, 1 absent. Motion carried.
- n. CD's – Motion by Wareham, supported by Christa Gardner to explore CD options for short term gains, and report at the May 8 meeting. AVIF
